**Re: Licence No. YZ2039 (the "Licence") – Surrender
Toronto-Lester B. Pearson International Airport**

This is further to our meeting with your President on May 16, 2002 and our letter of termination dated May 10, 2002 with respect to the Licence.

We agreed to continue discussions with you until June 14, 2002 concerning a new arrangement for a "neutral host" wireless system and we look forward to hearing from you. In order to permit those discussions to take place we agreed that the effective date of termination of the Licence would be adjusted from May 31, 2002 to June 30, 2002. Accordingly, the date by which all equipment must be removed in accordance with the terms and conditions of the Licence is also adjusted to July 30, 2002. The monthly fee is \$1,666.67 payable on June 1, 2002.

Our notice of termination dated May 10, 2002 in respect of licence no. YZ2778 with termination effective August 11, 2002 and removal of equipment by September 10, 2002 remains the same and is not affected.
