Re: Expiration of Licenses May 31, 2002

I confirm I have received your letter dated May 8th 2002.

As a brief overview, may I remind you it is more than one year since notice was given that licences would be renewed on the basis of a Neutral Host Solution together with a revised compensation arrangement.

In early March 2002, I extended the licenses at no rate increase to alleviate time pressures while we sought a technological solution and adequate compensation. I have always stressed the scheduling demands meant the timeline was crucial.

On April 29th this year, you collectively informed me that you had done all you could "to accommodate GTAA requirements". The gap between us remains \$25,000 each.

Your rights under licences expire at the end of May and you have been aware of this for many months.

Please comply by removing your equipment on or before the last day of May, 2002.
